POLICY STATEMENT:

POLICY DETAILS:

As one of North America's premier midstream service companies, an integral part of Equitrans' mission is supporting the communities where we live and work, while providing reliable energy infrastructure in a safe, efficient, and responsible manner. Consistent with our Vision, Mission, and Core Values, our Stakeholder Engagement and Community Investment Policy, and compliance with applicable environmental laws and policies, we are committed to supporting the fair treatment and meaningful involvement of all people regardless of race, color, national origin, or income.

Through this Policy, Equitrans and its subsidiaries pledge to do the following:

• Incorporate Environmental Justice into Project Planning. While advancing our fundamental business objectives, we will continue to evaluate opportunities to improve our performance with respect to environmental stewardship, protecting the air, land, and aquatic environments within our operating footprint, as well as our role in supporting the communities where we live and work. We will enhance our current practice to specifically consider environmental justice principles and feedback from neighboring communities during project planning to seek consensus.

• **Early, Meaningful, and Ongoing Stakeholder Engagement.** We believe that our local communities can provide valuable insight to help us fully understand the impact of our operations. We will seek to cultivate open, inclusive forums to foster collaboration and trust with environmental justice communities, providing opportunities for meaningful communication and input that will enable us to effectively plan and carryout our ongoing work in response to input on environmental justice issues.

• **Tribal and Indigenous Consultation and Engagement.** We are committed to engaging with tribal and Indigenous communities that may be impacted by our operations in an open and transparent manner to understand the unique needs of their distinctive history and culture. We respect the sovereignty and culture of each tribe and Indigenous community, and welcome bilateral information exchanges to fully appreciate the impacts of our activities and to effectively address concerns at the earliest possible juncture.
